LIMITED WARRANTY

Advanced Four Wheel Drive Systems warrants to the original owner of each vehicle, in which it has installed four-wheel drive capability, that it will repair or replace, without charge, any materials or parts supplied by **ADVANCED FOUR WHEEL DRIVE SYSTEMS** which are found to be defective in materials or workmanship (under normal use, service, and maintenance) for a period of 12 months or 12,000 miles; whichever occurs first, from the date the said vehicle was converted to four-wheel drive capability or was delivered to the original retail purchaser. With certain exceptions; Brake parts are warranted for 12 months or 12,000 miles; whichever comes first. All repairs, parts and service under this warranty will be preformed by **ADVANCED FOUR WHEEL DRIVE SYSTEMS**, or its duly authorized agent, and not by any other firm, dealership, agency, or person, unless specifically authorized by the Warrantor or unless other authorization has been given by Warrantor.

EXCLUSIONS OR LIMITATIONS

Advanced Four Wheel Drive Systems assumes no liabilities for:

1. Normal maintenance service, such as wheel balance, alignment, rotation, tightening of nuts, bolts and fittings, inspections and lubrications.
2. The replacement of maintenance items done in conjunction with normal maintenance services.
3. Failures, repairs replacements, service, or adjustments resulting from misuse, negligence, modification, alteration, accident, failure to perform reasonable, proper maintenance, use of parts not approved by **ADVANCED FOUR WHEEL DRIVE SYSTEMS**, or lack of performance of required maintenance service.
4. Consequential damages, claims for loss of use of a vehicle, inconvenience, or commercial loss.
5. Tow charges in excess of 25 miles or tow charges covered by individual auto insurance. Evidence of lack of towing insurance is necessary before tow claims can be paid.
6. Warranty replacement parts may be supplied by **ADVANCED FOUR WHEEL DRIVE SYSTEMS** at said companies option.
7. Freight charges on **ADVANCED FOUR WHEEL DRIVE SYSTEMS** supplied parts may be paid at **ADVANCED FOUR WHEEL DRIVE SYSTEMS** option.
8. This warranty does not apply to vehicles licensed or operated outside the United States. Warranties as such will be dealt on a case-by-case basis. Freight on warranty parts outside the United States will be the responsibility of the vehicle owner.
